DELEGATE A PERSON AUTHORIZED TO EXCHANGE WITH REVENU QUÉBEC AND THE CANADA REVENUE AGENCY

WHEREAS Riverside School Board is required to delegate a person who appears in the register of Enterprises as a person authorized to exchange with *Revenu Québec* and the Canada Revenue Agency;

WHEREAS the obligation of the Ministry of *Revenu Québec* that a resolution be adopted by the Council of Commissioners formalizing the person authorized to act on behalf of Riverside School Board;

IT IS MOVED by Commissioner Craig, seconded by Commissioner Aguiar, to appoint Mr. Sylvain Racette, Director General, as the person authorized to deal with *Revenu Québec* and the Canada Revenue Agency.
