Supporting signature from an elector of the English-language school board – Application for authorization of an elector who undertakes to run as a candidate

Qualified elector – *Act respecting school elections to elect certain members of the boards of directors of English-language school service centres (ASEESSC)*¹, sections 12 and 15:

Every person who, on polling day,

1. has attained 18 years of age,
2. is a Canadian citizen,
3. is domiciled in the territory of the English-language school board and has been domiciled in Québec for at least six months,
4. has not been disqualified from voting following a judgment rendered under section 288 of the *Civil Code of Québec*, and
5. has not been convicted within the last five years of an offence that is a corrupt electoral or referendum practice under this *Act*, the *Referendum Act* (chapter C-64.1), the *Act respecting elections and referendums in municipalities* (chapter E-2.2) or the *Election Act* (chapter E-3.3),

is a qualified elector.

Such an elector must also have the right to be registered on the list of electors of the English-language school board, i.e.:

- have a child admitted to the educational services of the English-language school board with jurisdiction over the territory where the elector's domicile is located;
- or have no children admitted to the educational services of an English-language school board or a French-language school service centre with jurisdiction over the territory where the elector's domicile is located.

Accordingly, a parent with one or more children enrolled only in the educational services provided by a French-language school service centre is not a qualified elector, since he or she does not meet these conditions.

Required number of signatures, section 206.7(4): The application for authorization must include supporting signatures from electors of the English-language school board concerned by the application for authorization (at least 10 for the seat of commissioner and at least 50 for the seat of chair)

Telephone number and email address

Under section 65 of the *Act respecting Access to documents held by public bodies and the Protection of personal information* (CQLR, c. A-2.1), the personal information that the Chief Electoral Officer is asking you to provide is confidential in nature. Accordingly, it will be used, subject to the exceptions stipulated in the Act, only for the purpose of processing the application for authorization of the elector by the persons empowered to do so.

The telephone number and email address are not mandatory, but will be used by the personnel concerned to communicate with you if needed. If you do not provide this information, the Chief Electoral Officer will communicate with you by regular mail and it may take longer to process the application for authorization.
